DoD Definitions of Domestic Abuse and Domestic Violence

Domestic Abuse (DA)

- Domestic violence, or a pattern of behavior resulting in emotional or psychological abuse, economic control, or interference with personal liberty that is directed toward a person who is a:
 - Current or former spouse;
 - Person with whom the alleged abuser shares a child in common;
 - Current or former intimate partner with whom the alleged abuser shares or has shared a common domicile; or
 - Person who is or has been in a social relationship of a romantic or intimate nature with the accused and determined to be an intimate partner (as defined in this issuance).

DoD Definitions of Domestic Abuse and Domestic Violence

Domestic Violence (DV)

- An offense under the U.S.C., the UCMJ, or State or local law involving the use, attempted use, or threatened use of force or violence against a person, or a violation of a lawful order issued for the protection of a person, who is a:
 - Current or former spouse;
 - Person with whom the alleged abuser shares a child in common;
 - Current or former intimate partner with whom the alleged abuser shares or has shared a common domicile; or
 - Person who is or has been in a social relationship of a romantic or intimate nature with the accused and determined to be an intimate partner (as defined in this issuance).

DoD Definitions of Domestic Abuse and Domestic Violence

Intimate Partner Violence (IPV)

- Within the context of eligibility for FAP services, a person who is or has been in a social relationship of a romantic or intimate nature with the alleged abuser, as determined by the length of the relationship, the type of relationship, and the frequency of interaction between the person and the alleged abuser. An intimate partner is informed by, but not limited to, the totality of factors such as:
 - Previous or ongoing consensual intimate or sexual behaviors.
 - History of ongoing dating or expressed interest in continued dating or the potential for an ongoing relationship (e.g. history of repeated break-ups and reconciliations).
 - Self-identification by the victim or alleged abuser as intimate partners or identification by others as a couple.
 - Emotional connectedness (e.g., relationship is a priority, partners may have discussed a future together).
 - Familiarity and knowledge of each other's lives.

FAP Domestic Abuse Data and Metrics

The data provided includes counts of reports, met criteria incidents, unique victims, and unique abusers of domestic abuse FY 2012-FY2022. The data source is the DoD Central Registry end-of-fiscal year snapshot file for each referenced fiscal year. The Department has undertaken numerous efforts to improve data quality over time. There are several data caveats for consideration:

- Reports of abuse in FY2012-FY2020 were calculated by the sum of met criteria rows and rows that did not meet criteria. Reports in FY2021-FY2022 were calculated by abuse type, using the alleged abuse code fields.
- Historical counts from FY2012-FY2015 reflect new, more accurate calculation methods and differ from the methods employed at that time.
- Counts of unique victims or abusers means that a victim (or abuser) is counted only once within a category regardless of the number of incidents of abuse in which that victim (or abuser) may have been involved.

FY2020 – FY2023 Changes Made To Policy

- DoDI 6400.06: Initial issuance. Expanded intimate partner definition to include those in dating relationships, added victim choice in instances of sexual abuse, allows victims to disclose abuse to certain individuals without forcing an unrestricted report, and provides guidance for expedited transfer.
- DoDI 6400.06 change 2: Changes domestic abuse mandatory training from annually to frequency as determined by the Military Departments.
- DoDM 6400.01 Volume 3 change 1: The change incorporates the GAO recommendation to modify IDC membership and voting guidelines, and amends responsibilities of health care providers as core IDC members.



FY2020 – FY2023 Updates

- Reissued policy expanding the definition of intimate partner, December 2021
- Military Community & Family Policy (MC&FP) assumed leadership of the Department's CCR with the Military Community Advocacy (MCA) directorate to serve as a sustained, coordinating function that brings together all entities that have equity in an incident of domestic abuse.
- CCR stood up a Law Enforcement Working Group with Service specific expert representatives to consult on and facilitate activities to improve law enforcement response in line with logic model outputs.
- Completed prevention analysis and environmental scan of Services' prevention efforts and coordination with DoD components addressing other violent/harmful behaviors.



FY2020 – FY2023 Initiatives

- Updated the "FAP for Leaders" course with a name change to, "OSD –101
 Abuse Within Relationships and Families: For Leaders" and transitioned it
 from MilLife Learning platform to the JKO platform, which is more
 universally accessible to Service members, the identified audience for
 the training.
- Coordinated with Service Chaplains to discuss the 5Ws of mandatory training requirements for Chaplains and how FAP training for Chaplains is tracked/collected and forwarded to OSD.
- Completed the "FY2023 Family Advocacy Program Non-DoD Entry Point Environmental Scan" scan, which was congressionally mandated.



FY2020 – FY2023 Initiatives (cont.)

- Revamped the Domestic Abuse Victim Advocate Locator on MilitaryOneSource.mil.
- MCA customized support plan for enhancing processes and protocols for DoD CCR to include training, risk and lethality assessment, and information sharing and strategic communications.
- CCR leads the Executive Steering Committee meeting quarterly.
- MC&FP developed and disseminated a department wide Domestic Abuse Outreach and Engagement communications plan, "United Against Domestic Abuse" in February 2022.
- MC&FP compiled and disseminated customizable communications materials to public affairs leads of the Military Services, to share the plans across public affairs networks.
- MCA conducted Deputy's Workforce Council (DWC) directed Communication Site visits to four installations across all branches to determine strengths and barriers to the execution of the communication plans.
