Q2: In March 2022, the U.S. Military Entrance Processing Command (USMEPCOM) launched the Military Health System (MHS) GENESIS across the nation. MHS GENESIS highlights potential medical factors for disqualification. MHS GENESIS was developed to increase efficiencies; however, the Committee was informed by recruiters in March 2023, that the adoption of the new platform has impacted the Services contracting production due lengthy processes. The Committee wants to determine whether there are ways to eliminate unnecessary barriers to military service, as well as remove or reduce extended timelines that cause the military to lose out on talent. In addition, the Committee understands the Defense Department is using medical data collected from MHS GENESIS to review whether 38 medical conditions that now disqualify individuals from military service should remain disqualifiers.

a. DHA: Please describe the process and purpose of the review of disqualifying medical conditions and how MHS GENESIS is used in that process.

When MHS GENESIS was rolled out in March 2022, the new access to authoritative medical information for applicants resulted in an increased number of medical records requests for applicants. In an effort to reduce these increased records requests, the Director for OSD Accession Policy directed a review of DEPARTMENT OF DEFENSE INSTRUCTION 6130.03 VOLUME 1 MEDICAL STANDARDS FOR MILITARY SERVICE: APPOINTMENT, ENLISTMENT, OR INDUCTION. Approximately 271 disqualifying medical conditions were identified that are disqualifying if they occur anytime in an applicant's life. These conditions necessitate a medical records request from the USMEPCOM medical provider if they are ever diagnosed in an applicant's history.

OSD Accession Policy directed the USMEPCOM Command Surgeon review these 271 conditions and provide recommendations for each condition as to whether the lifetime disqualification could be limited to a shorter time frame for which the condition would be disqualifying and for which medical records would need to be requested. The purpose of this review was two-fold: 1) reduce records requests for applicants with specific disqualifying medical conditions and 2) allow individuals with these conditions who have not had any symptoms or received any treatment for in the specified timeframe to be qualified for service (rather than disqualified).

The rollout of MHS GENESIS and the increased medical records requests that came from the rollout instigated the development of the review. However, MHS GENESIS was not utilized in the development of the review.

b. DHA: How was the review developed? Were subject matter experts included (internal or external)? Who participated in the design of the review?

The USMEPCOM Command Surgeon considered two factors in reviewing the 271 lifetime disqualifying conditions in determining whether a reduced disqualifying timeframe could be applied. They were:

- Does the specified condition confer a harm or vulnerability that does not decrease over time?
- Does service in the military exacerbate the condition?

A "yes" to either of the two factors eliminated the condition from consideration. Applying these factors, and utilizing his experience as a military physician, the Command Surgeon developed a list of 51 medical

conditions for which a reduced timeframe for disqualification was recommended. Those recommendations were limited to 0.5 years, 3 years, 5 years, or 7 years. This list was socialized with the Services by OSD Accession Policy for feedback from their medical departments. Concurrence was received by two of the Services for the list as provided while two of the Services provided feedback on conditions to be removed and timeframes to be adjusted. If two Services recommended a condition be removed, it was removed. If only one Service recommended it be removed, then 2 years were added to its disqualification timeframe (with a cap at a 7-year maximum) and the condition was kept on the list. This Service review process resulted in a final list of 38 conditions for which the lifetime disqualification in DODI 6130.03 was changed to 0.5, 3, 5 or 7 years.

The initiative was titled the Medical Accession Record Pilot (MARP) and briefed to the Accession and Retention Medical Standards Working Group (ARMSWG)* which has responsibility to review both the accession and retention medical standards on a recurring basis. After questions from the ARMSWG were addressed, the MARP was implemented in June 2022 by OSD Accession Policy. This pilot is limited to applicants processing through USMEPCOM only and does not apply to applicants processed through the Department of Defense Medical Examination Board (DoDMERB). On April 7, 2023, in consultation with the Services and their medical representatives, OSD Accession Policy added an additional 11 standards to the MARP.

*The ARMSWG recommends military accession medical standards and develops policy recommendations utilizing evidence-based information provided by analysis and research. The standards are based on the operational needs of the Military Services and are designed to ensure that individuals are physically and psychologically qualified, capable of performing strenuous military duties, often associated with wartime activities.

The co-chairs of the ARMSWG are the Deputy Assistant Secretary of Defense (Military Personnel Policy) and the Principal Deputy Assistant Secretary of Defense (Health Affairs). The voting members are the two chairs and the Asst. Secretary of the Army (M&RA); Asst. Secretary of the Air Force (M&RA); CG Director Reserve & Military Personnel (CG-13); Asst. Secretary of the Navy (M&RA) and Deputy Chief of Staff (M&RA), USMC. The advisory members are the Surgeon General of the Army; Surgeon General of the Air Force; Chief Medical Officer, U.S. Coast Guard; Joint Staff, Director Manpower & Personnel (JS/J1); Surgeon General of the Navy; Joint Surgeon, National Guard Bureau; Joint Staff Surgeon and Deputy Chiefs of Staff for Personnel (Service 1s).

c. DHA: What objectives, outcomes, and metrics are being examined as part of the review?

The DoD is continuously assessing the effectiveness of the pilot program and will continue to capture accession and attrition data of the applicants who were accessed using the MARP standards. MARP data is obtained from USMIRS (the USMEPCOM processing system). TAB A has additional information. MHS GENESIS is not utilized for this data tracking.

The primary objective and desired outcome is to reduce the time required for the Military Services to complete enlistment contracting actions and enable more applicants to qualify for enlistment without the time-consuming requirement of requesting additional documentation and/or a medical waiver. Key metrics include:

- The number of applicants with an applicable MARP code
- The number of applicants accessed using the MARP

- The number of applicants who have shipped
- The number of applicants accessed using the MARP who have separated from Service
- The reasons for separation, i.e., was it MARP related or was the applicant separated for a different reason
- Length of service for separated applicants

d. DHA: Describe the demographic makeup of the sample being reviewed (include breakout by gender).

The pilot review is only applicable to the applicants who have a diagnosis that is listed on the MARP. At this time, there have been 1370 applicants processed through a MEPS who have a diagnosis that is on the MARP: 1191 males and 179 females. Out of the 857 enlistments, 766 were male while 91 were female.

Requested information located in TAB A.

e. Military Services: Identify unique and the most frequent medical conditions leading to disqualification and waivers (specify both) being reviewed for females.

Women-specific health issues make up a small percentage of overall medical disqualifications from service (<5%). Additionally, the women-specific medical conditions which do disqualify from service are mostly unique in that they are disqualifying based solely on recent symptomatology and impact to activities of daily living. When symptoms resolve and activities of daily living are no longer impacted, the disqualification goes away. This separates these conditions from other disqualifying medical conditions which often require long timelines for resolution or are permanent in nature.

The most frequent medical conditions that women are disqualified for are the same conditions men are more likely to be disqualified for. They include eye/vision disorders, musculoskeletal conditions (including the spine, the extremities, and neck), and psychiatric disorders. These conditions also have the largest number of requested and approved waivers.

TAB B provides supporting data.

g. Military Services: Who has authority (e.g., statutory, policy, or regulatory) to determine disqualifying conditions?

Per DoDI 6130.03 Volume 1, the United States Military Entrance Processing Command (USMEPCOM) and the DoD Medical Examination Review Board (DoDMERB) will render medical qualification decisions.

h. Military Services: Who has authority (e.g., statutory, policy, or regulatory) to authorize medical waivers?

Also, per DoDI 6130.03 Volume 1, the individual Services may initiate and request a medical waiver. Each DoD Component's waiver authority for medical conditions will make a determination based on all available information regarding the issue or condition, as well as the specific needs of the Military Service.
