## SECURITY AWARENESS NOTICE

#### SAFETY/HAZARD AWARENESS NOTICE

- [1] (U) No articles shall protrude from or be visible on the uniform; e.g., pens, key chains, combs, cigarettes, pagers, cellular phones, etc. Protruding objects detract from a professional military appearance and could distort the uniform shape.
- [2] (U) While in uniform, it is inappropriate and detracts from military smartness for personnel to have their hands in their pockets.
- [3] (U) When walking from point to point while in uniform, it is inappropriate to be smoking, using tobacco products, or to be eating and / or drinking.

- 3. (U) Care, cleaning, and replacement of U.S. Navy uniforms.
- a. (U) Washing, dry cleaning, alterations and repairs are the member's responsibility.
- b. (U) Follow manufacturer's labels inside uniform items for proper cleaning procedures and requirements.

- e. (U) Uniforms should be stored on hangers. If uniforms are to be stored for a long time, they should be cleaned and packed in an airtight plastic bag with a packet of desiccant (drying agent).
- f. (U) The Clothing Replacement Allowance (CRA) is an annual payment provided for replacing a minimum quantity of each required uniform.

- (1) (U) Requirements ensure that hair does not interfere with proper wearing of military headgear and safety equipment.
- (2) (U) Varying hairstyles, including Afros, are permitted providing criteria of maximum length, bulk, and tapered neck and sides are met.
- (3) (U) Hairpieces may be worn only for cosmetic reasons to cover natural baldness or physical disfigurement.
  - (a) (U) They will present a natural appearance and conform to all grooming standards.
  - (b) (U) They may not interfere with the performance of duty or present a safety or become a foreign object damage (FOD) hazard.
- c. (U) Hair standards for men

- (1) (U) Hair above the ears and around the neck shall be tapered upward at least 3/4" and no more than 3/4" outward to blend with hairstyle.
- (2) (U) Hair shall be no longer than four inches and must NOT:
  - (a) (U) Touch the collar.
  - (b) (U) Extend below the eyebrows.
  - (c) (U) Exceed two inches in bulk (the distance that the mass of hair protrudes from the scalp.
  - (d) (U) Be plaited (tightly woven hair braided close to the scalp) or braided while in uniform or duty status.
- (3) (U) One natural, fore and aft, narrow part may be cut, clipped or shaved into the hair.
- (4) (U) The unique quality and texture of curled, kinked, waved and straight hair are recognized. Sometimes the 3/4" taper at the back of the neck may be

(b) (U) The taper may combine with a line at the back of the neck. (5) (U) Men may shave their heads if done every day. Men may NOT shave their heads for: (a) (U) Faddish hair styles (a) (U) Display Slide: Grooming: Faddish Hair Styles [1] (U) Faddish styles are followed for a short time to an exaggerated level. They are generally conspicuous and detract from a professional appearance. [2] (U) Haircut with a distinct visible line (bowl cut or high and tight). (b) (U) Affiliation with an extremist group.

(6) (U) Faddish styles and outrageous multicolored hair are NOT authorized.

- (7) (U) Keep sideburns neatly trimmed and tailored in the same manner as the haircut. They shall:

  - (c) (U) End with a clean-shaven horizontal line.
- (8) (U) Mustaches will be kept neatly and closely trimmed.
  - (a) (U) No portion of the mustache shall extend below the line of the upper lip.
  - (b) (U) A mustache shall NOT be:
    - [1] (U) Beyond a horizontal line extending across the corners of the mouth.

- (2) (U) For men, fingernails shall NOT extend past the fingertips.
- e. (U) Female Grooming
  - (1) (U) Acceptable Hairstyle Criteria.
    - (a) (U) Hairstyles and haircuts shall present a professional and balanced appearance.
- (b) (U) Appropriateness of hairstyle shall be evaluated by its appearance when headgear is worn. All headgear shall fit snugly and comfortably around the largest part of the head without distortion or excessive gaps. Hairstyles will not interfere with the proper wearing of headgear, protective masks or equipment.
  - (c) (U) When headgear is worn, hair shall not show from under the front of

- (3) (U) When wearing the jumper uniform (crackerjacks), hair may extend a maximum of 1 1/2" below the top of the jumper collar.

- (5) (U) Lock Hairstyle
  - (a) (U) Consists of one section of hair that twists from or near the root to the end of the hair and creates a uniform ringlet or cord-like appearance.
  - (b) (U) May be worn in short, medium, and long hair lengths.
  - (c) (U) Must continue from the root to the end of the hair in one direction (no zig-zagging, curving, or ending before the end of the lock to dangle as a wisp or loose hair) and should encompass the whole head.
  - (d) (U) Locks partings must be square or rectangle in shape in order to maintain a neat and professional appearance.
  - (e) (U) Can be loose (free-hanging where no hair is added to the lock once it is started other than hair extensions that are attached at the end of the natural hair).

(5) (U) Display Slide: Female Grooming: Locks / Ponytails.

(U) Ref: Uniform Regs: 2201.1.

- (f) (U) When worn loose, locks will be spaced no more than three-eighths of an inch apart, diameter/width will not exceed three-eighths of an inch, and locks will be tightly interlaced to present a neat and professional military appearance.
- (g) (U) Locks may also be worn in a bun provided all hair grooming requirements are met. Locks may not be worn in combination with other hair styles (e.g. twists, braids).
- (h) (U) New growth (defined as hair that naturally grows from the scalp and has not yet been locked) will not exceed one-half inch at any time.
- (6) (U) Pony Tails
  - (a) (U) Authorize wear of a single braid, French braid, or a single ponytail in Service, Working, and PT uniforms.
  - (b) (U) Foreign material, such as beads and decorative items, shall not be braided into the hair.

- (c) (U) The end of the braid or ponytail may extend up to three inches below the lower edge of the collar of the shirt, jacket or coat.
- (7) (U) Hairstyles with multiple braids may be worn; (corn rows, French braids, etc.).
- Rows / Braids.

(7) (U) Display Slide: Female Grooming: Bun /

- (a) (U) Braids shall be approximately 1/4" inch in diameter and tightly woven.
- (b) (U) Foreign material, such as beads and decorative items, shall not be braided into the hair.
- (8) (U) Appropriateness of hairstyle is also judged by its appearance when headgear is worn.
- (9) (U) Long hair, including braids, must:
  - (a) (U) Be neatly and inconspicuously fastened, pinned or secured to the head and may not dangle free at any point.

- (b) (U) Not be lopsided or extremely asymmetrical.
- (10) (U) The bulk of the hair shall not exceed two inches.
- (11) (U) A maximum of two (2) small barrettes, combs or clips similar to hair color may be used.
- (12) (U) Hair accessories must be consistent with the hair color.
  - (a) (U) A maximum of two small barrettes, similar to hair color, may be used.
  - (b) (U) Bun accessories (used to form the bun), are authorized if completely concealed.
  - (c) (U) Additional hairpins, bobby pins, or small rubber bands, may be used to hold hair in place, if necessary.
  - (d) (U) The intent is for pinned-up hair to be styled in a manner that prevents loose ends from extending upward or outward from the head.

- (e) (U) For example, when using barrettes or hairpins, hair will not extend loosely from the head; when hair is in a bun, all loose ends must be tucked in and secured.
- (f) (U) Hair accessories shall not present a safety or foreign object damage (FOD) hazard.
- (g) (U) Hair nets shall not be worn unless authorized for a specific type of duty.
- (h) (U) Headbands, scrunchies, combs, claws and butterfly clips, are examples of accessories that are not authorized.
- (13) (U) Hair may not be outrageously multicolored or faddish, including shaved portions (except neckline), or have designs cut or braided into it.
