- **a.** Military Services: Please provide:
  - i. The number of women's health clinics and the number of walk-in contraceptive clinics in your Service.
    - Medical Treatment Facilities on 51 Department of the Air Force instillations house Women's Health Nurse Practitioners and/or Gynecologic Surgeons and Obstetricians
      - Service members and beneficiaries may also receive women's health care from other primary care providers in the MTF such as Family Medicine Physicians, Flight Physicians, Physician Assistants, or Family Nurse Practitioners
    - There are currently 70 Walk-In Contraception Services (WiCS) locations on DAF installations
    - These WiCS are all located within Military Treatment Facilities (MTFs) under the authority/direction/control of the Defense Health Agency
    - The following two slides include a list of the facilities offering WiCs, their locations and dates and times of services

- m. Army, Marine Corps, and the Department of the Air Force:
  - i. What kinds of women's health care services/invasive examinations are provided by unitembedded providers (e.g., Army medics), if any?
    - Embedded providers (e.g. Flight Surgeons, IDMTs) may provide limited preventative gynecologic care such as pap testing and testing/treatment for sexually transmitted infections
    - Treatment for urinary tract infections or uncomplicated vaginitis may also be done by embedded medics
    - Integrated operational support teams (IOS) do not provide women's health or invasive examinations as a part of their scope of practice



- m. Army, Marine Corps, and the Department of the Air Force:
  - ii. What is the extent and the range of services performed by embedded providers in terms of contraception, preventive care, hormonal issues, and other reproductive healthcare?
    - In addition to those elements listed on the previous slide, embedded providers will provide basic contraception care, to include prescription of oral contraceptive pills
  - iii. Are servicewomen referred to a medical facility for such care?
    - Airmen and Guardians requiring further women's health or reproductive health care are referred to the Military Treatment Facility
    - Servicewomen may be referred to a Primary Care provider (e.g. Family Medicine) or a Women's Health provider (Women's Health Nurse Practitioner or Gynecologic Surgeon and Obstetrician) for further evaluation



- m. Army, Marine Corps, and the Department of the Air Force:
  - iv. Describe the scope and limitations of care which may be provided by unitembedded medical providers both at home station and while deployed.
    - Scope of care provided by embedded providers is limited by:
      - Training and credentials of individual providers embedded providers come from a variety of training backgrounds with subsequent variation in the scope of care they are credentialed to provide
      - Provider experience and clinical currency providers who do not regularly provide women's health or reproductive health care may not have the experience and/or clinical currency to provide this care
      - Location as well as resources and equipment (e.g. examination equipment, testing equipment, etc.)



- n. DHA/Military Services: Do the DHA or Military Services plan to open more women's health clinics or contraceptive clinics in the future? If so, where and what is the projected timeline?
  - Defer to DHA regarding plans to open further Women's Health or Contraceptive Clinics within the Military Treatment Facilities
  - The DAF has no ongoing plans to open Women's Health Clinics or Contraceptive Clinics outside of Military Treatment Facilities
